

Spray Park & Tot Lot Rules and Regulations

The Crestmont Homeowners Association (CHOA) amenities are for the use of Members of the Crestmont Homeowners Association (the "Association") and their guests and are in accordance with the City of Calgary Bylaws.

All such Members (residents) and their guests are permitted the use of the public lands and private amenities entirely surrounding the facility at their own risk, and subject to the following rules and regulations:

Introduction:

It is the intent of the CHOA to maximize the safe enjoyment of the amenities by all Crestmont Members (residents). To that end, the following rules have been established and they apply to all Members and their guests.

In all matters, whether or not specifically covered herein, courtesy and common sense shall prevail. It is the responsibility of all Members to know and understand the rules of the CHOA.

The CHOA may make other rules and regulations if in its judgment they are required for the safety of Members (residents) and guests; for the care and cleanliness of the amenities; and for preservation of good order therein.

Note that there is no lifeguard on duty. Proper swimming attire must be worn at all times. No bathing in the spray park is permitted. Alcoholic beverages are not permitted in the park area or any of the grounds.

Prohibitions:

No person shall at any time have or take on the CHOA lands and amenities located on public parks, walkways and green spaces within the community boundaries:

- any glass bottles;
- any other glass product;
- any intoxicating liquor, drug or similar substance;
- any dog unless licensed and in accordance with City Bylaw;
- any vehicle (motorized or otherwise, other than motorized wheelchairs) and other than a bicycle, tricycle, and battery operated ride on toys
- any open fire; or
- any snowmobile.

Smoking and/or vaping is prohibited in and around the Crestmont Hall.

All of the above are strictly prohibited at all times.

Skateboarding, Rollerblading, Scooters & Ride-On Toys:

Skateboarding is not permitted on commercial property as well as any ornamental structures/features and benches. Bikes and other ride on toys are not permitted in the spray park area. Helmets are strongly recommended and parental supervision is advised.

Spray Park Area

All children who are not yet toilet trained must wear a training pant and a swim suit.

This area is unsupervised with no lifeguard on duty. All Members must take personal responsibility for their children and guests.

Prohibited within the spray park area.

- Bikes, scooters, skate boards & ride on toys
- Animals or pets of any kind

Park Hours of Operation:

The spray park is open seasonally (weather permitting) from June 1 to September long weekend. Hours of Operation are 7 days a week from 10:00am to 9:00pm. The tot lot is open year round.

Member & Guest Policy:

- Members must complete the Spray Park Waiver prior to admittance to the spray park.
- Members in good standing are permitted a maximum of five (5) guests per household per day.
- Members who are under the age of 16 are permitted a maximum of two (2) guests per day.
- Guests must be accompanied by a Member (resident) at all times.
- Requests for more than 5 guests can be made through the Facility Manager, however approval is not guaranteed. The CHOA reserves the right to deny requests based on capacity of the park.
- Guests must observe all posted signage and must complete a Spray Park Waiver prior to park entry.
- Over-night parking is prohibited.
- Member Access: all Members must display a branded keyscan card with current year access identification. Keyscan cards may be purchased at the office for a fee of \$10.00 each. A card deposit may be required.
- Members must check in at the office reporting any guests that are attending with them.
